

Storage Agreement At Whistle Bare Campground

All storage rentals are payable in advance. No refunds for cancellations or early removal of items.

Whistle Bare Campground Ltd is a gated property. To gain access to your unit in storage, a proximity gate card is needed. If you sign up for a 6 month or 1 year contract, you will receive a complementary gate card per site. This card can be deactivated or reactivated as storage is needed. Proximity gate cards can be purchased for \$25.

The undersigned, represents and warrants that the information set out in this Storage Agreement is true and up-to-date and correctly describes the unit (the "Unit") to be placed on the Campground Lot set out above located on the Whistle Bare Campground Ltd. property (the "Campground").

I understand that failure to pay rent and other sums due, can result in deactivation of the Proximity Gate Card associated with this rental agreement and may result in Whistle Bare Campground Ltd. making a claim for lien under the Repair and Storage Liens Act, R.S.O. 1990, c. R.25, as amended.

I acknowledge that I am storing my Unit at the Campground at my own risk and that I am totally responsible for theft, vandalism, loss or any other damage or destruction that may occur to the Unit. I shall not hold, Whistle Bare Campground Ltd. its officers, directors, employees, servants, or agents (the "Releasees") liable for any personal theft, vandalism, loss or any other damage or destruction to the Unit or injury sustained by me or any invitee of mine while attending on or at the Campground. I release, and undertake to indemnify and save harmless, the Releasees, from any and all claims and actions for theft, vandalism loss or any other damage or destruction to the Unit or injury sustained by me or any invitee of mine and from all actions, claims, and demands of every nature and kind whatsoever which I, or my invitees and their heirs, executors, administrators and assigns may now or at anytime hereafter have resulting directly or indirectly from same; and agree to indemnify and hold harmless the Releasees from any and all liability for any damage to property of, or personal injury to, any third party, resulting from the storage of the Unit on the Campgrounds or my or any of my invitees attendances at the Campgrounds. I acknowledge and agree that the Releasees are not liable or responsible for any damage to the Unit caused by fire, theft, flying objects, wind, snow, rain, acts of God or any other cause.

I agree to place and maintain fire, theft, damage and liability insurance on my Unit so long as such Unit is on the Campground and also on any and all vehicles which I may use to access the Campground. I have inspected the storage site and I am fully aware of the security elements, or lack thereof, that exist and I am aware of and willing to accept total responsibility for the possible perils to which my Unit will be subject to.
